**PAYMENT**

Permit fees are \$4,500 for a Series, \$4,000 for a Mini-series, and \$3,500 for a Feature, MOW or Pilot plus HST/GST (5% for AB, BC, MB, NT, NU, PE, SK & YT, 13% for NB, NL, & ON and 15% for NS). If the series is then picked up an additional \$1,000 is payable to “top-up” the permittee membership to that of a series permit for season one. A separate permittee membership would need to be acquired for a second or subsequent season. Payment must be received with application.

*All applicants for permittee membership are required to provide the top-sheet of the production budget to the CMPA in order to confirm the administration fees owing to the CMPA. Should a production choose not to provide the budget top sheet, it may forgo delivery of this information by remitting the maximum administration fees payable under the applicable union and guild agreements.*
